

PERMIT TO ALLOW MINOR USE OF AN AGVET CHEMICAL PRODUCT

FOR CONTROL OF TWO-SPOTTED MITE IN FIELD GROWN HEAD LETTUCE

PERMIT NUMBER - PER14696

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows any person to claim that the product can be used in the manner specified in this permit.

Product to be used:

VERTIMEC MITICIDE/INSECTICIDE [APVMA No. 50772]

Plus other REGISTERED PRODUCTS

Containing: 18 g/L of ABAMECTIN as their only active constituent.

VANTAL UPGRADE MITICIDE/INSECTICIDE [APVMA No. 67524]

Plus other REGISTERED PRODUCTS

Containing: 36 g/L of ABAMECTIN as their only active constituent.

Critical Use Comments:

- DO NOT apply more than one (1) application per crop to avoid potential development of TSM resistance. Where more frequent control of TSM is required other approved chemicals with a different MoA Group should be rotated to avoid resistance development.
- It is essential to apply sufficient volume for even coverage and better penetration of plants using a knapsack or boom spray. Use the higher rate for high pest pressure.
- Effective control of the two-spotted mite will be ensured only if it is sprayed in accordance with label instructions using correctly calibrated spray equipment to coincide with and contact a susceptible life stage (adults and nymphs). It is most effective if used as part of an overall IPM strategy.

Withholding Period:

DO NOT harvest for 3 DAYS after application.

Jurisdiction:

ALL STATES except VIC.

Note: Victoria is not included in this permit, as their *Control-of-Use* legislation means a permit is not required to legalise this off-label use in that state.

Additional Conditions:

This PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the DETAILS and CONDITIONS of this permit.

To Avoid Crop Damage

The sensitivity of some species and varieties of the crops to be treated under this permit has not been fully evaluated. It is advisable, therefore, to only treat a small number of plants to ascertain their reaction before treating the whole crop.
