Containing: 825 g/L PETROLEUM OIL as the only active constituent.

JMS STYLET-OIL HORTICULTURAL MINERAL OIL (APVMA No. 59091)
PLUS OTHER REGISTERED PRODUCTS
Containing: 826 g/L PETROLEUM OIL as the only active constituent.

D-C-TRON COTTON SPRAY OIL (APVMA No. 52558)
PLUS OTHER REGISTERED PRODUCTS
Containing: 827 g/L PETROLEUM OIL as the only active constituent.

SACOA CROPSHIELD SPRAY ADJUVANT (APVMA No. 53998)
PLUS OTHER REGISTERED PRODUCTS

EMPOWER SPRAY ADJUVANT (APVMA No. 56561)

RESTRAINT:

DO NOT spray when shade temperature exceeds 32°C or when soil is dry and trees are suffering from moisture stress.

Directions for Use:

Crop	Pest	Rate
Persimmon	Scale Insects	3 L/100 L

Critical Use Comments:

- Apply using ground-based application equipment.
- Apply during dormant period up to green tip or bud swell.
- Apply in sufficient volume to ensure adequate coverage of all plant surfaces.
- Application is most effective against young crawler stages.
- Follow all crop safety precautions on the product label.

Withholding Period:

Harvest: Do not harvest for 1 day after application.

Jurisdiction:

All States and Territories, except VIC.

Note: Victoria is not included in this permit, as their Control-of-Use legislation means a permit is not required to legalise this off-label use in that State.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

The holder of the permit must notify the APVMA of new information, including relevant information in accordance with section 161 of the Schedule to the *Agricultural and Veterinary Chemicals Code Act 1994*, in accordance with the obligation imposed by that section.

To Avoid Crop Damage

The sensitivity of the crop to be treated under this permit has not been fully evaluated. It is advisable to only treat a small area to ascertain the reaction before treating the whole crop.
