

PERMIT TO ALLOW EMERGENCY USE OF A REGISTERED AGVET CHEMICAL PRODUCT FOR CONTROL OF FALL ARMYWORM IN BULB ONIONS

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. CONDITIONS OF USE

Products to be used:

SUCCESS NEO INSECTICIDE (APVMA No. 64109)

Containing: 120 g/L SPINETORAM as the only active constituent.

Restraints:

Comply with all restraints on the product label.

Directions for Use:

Crop	Pest / Disease	Rate
Bulb onions	Fall Armyworm (Spodoptera frugiperda)	200- 400 mL/ha
Bulb onions	Fall Armyworm (Spodoptera frugiperda)	200- 400 mL/ha

Critical Use Comments:

- Regularly scout crops to monitor for eggs and larvae. Treat when pests appear, targeting eggs at hatch or early instar larvae before the pest becomes entrenched.
- Use the higher rate when insect pressure is high.
- Apply by boomspray or equivalent equipment, in enough water to ensure thorough coverage of the crop.
- DO NOT apply more than three (3) applications per season, with a minimal retreatment interval of 7 days.
- Do not use more than two consecutive applications of Group 5 insecticides. Rotate to another class of effective insecticides for at least one application.
- Refer to the Insecticide Resistance Management statement on the product labels to prevent or delay the development of resistance.

Withholding Period:

HARVEST: Do not harvest for 3 days after application.

GRAZING: Do not graze or feed treated crops to livestock.

Jurisdiction:

All States and Territories, except VIC.

Note: Victoria is not included in this permit, as their Control-of-Use legislation means a permit is not required to legalise this off-label use in that State.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

To Avoid Crop Damage

The sensitivity of the crop to be treated under this permit has not been fully evaluated. It is advisable to only treat a small area to ascertain the reaction before treating the whole crop.

Export of treated produce

MRLs can be found in the *Agricultural and Veterinary Chemicals Code (MRL Standard) Instrument 2019.* MRLs apply only to produce marketed and consumed in Australia. If treated produce is to be exported, residues must not exceed the limits/tolerances of the importing country.
