Proposed investments in 2023/24

Each year, custard apple industry representatives meet as advisory panels to discuss investment recommendations in line with the custard apple Strategic Investment Plan (SIP). At these meetings, the panels are provided with a financial forecast and an investment analysis of current investments. Based on this information, they provide Hort Innovation with advice on priorities for investment for the upcoming year.

The custard apple advisory panel met on October 18, 2022, to discuss, provide advice on, and prioritise recommendations on investments in 2023/24. The panel decided to hold further investments and consolidate funds for further discussion in 2023/24
