# Pyrethrum Fund Annual Investment Plan 2023/24



## Proposed investments in 2023/24

Each year, pyrethrum industry representatives meet as advisory panels to discuss investment recommendations. At these meetings, the panels are provided with a financial forecast and an investment analysis of current investments. Based on this information, they provide Hort Innovation with advice on priorities for investment for the upcoming year.

The pyrethrum R&D advisory panel has not met to discuss, provide advice on, and prioritise recommendations on investments in 2023/24 due to being fully invested.
