The SIAP was held on May 17th and 18th, 2017. The focus was on the next 5 years and covered finances, the summerfruit Strategic Investment Plan (SIP) 2017-2021, new trade and marketing investment concepts and the development of R&D concepts.

Richard de Vos chaired this meeting and provided an overview to members outlining the objectives, governance and scope of operation of the panel.

Stuart Burgess presented a financial update which included:

- 5 Year financial forecast
- Current projects

The SIAP discussed and prioritised all strategies in the Strategic Investment Plan (SIP) 2017-2021.

Michael Rogers GM of trade and Sam Lawrence trade manager conducted an update which included SIAP discussion and advice on the following investment opportunities:

- Export readiness & market access
- China export facilitation
- Export strategy to be researched
- Trade Events: Australia Fresh (WOP Vs Gulfood)

A marketing session was conducted by Graeme Yardy GM marketing and Dianne Phan Summerfruit and trade marketing manager covering:

- Developing an Export Marketing Plan (Now in Season)
- Category Management and the concept: Supply Chain Quality Support
- Developing a Domestic Marketing Plan (3 years)

Sharyn Casey presented investment opportunities for the summerfruit industry in the leadership fund under R&D Co-investment.



The following research and development concepts were discussed for SIAP advice:

- Summerfruit communications project
- Experimental Summerfruit orchard (Tatura) phase 2
- Improving the biosecurity preparedness of Australian horticulture for the exotic spotted wing drosophila (Drosophila suzukii)
- Review of the national biosecurity plan for the Summerfruit industry
- Xylella R&D program

An ideation session was conducted with the SIAP whereby new concepts for possible future investment where discussed in alignment to the summerfruit SIP 2017-2021.
