SIMPLEX 500 SC HERBICIDE (APVMA No. 68981)

PLUS OTHER REGISTERED PRODUCTS

Containing: 500 g/L SIMAZINE as the only active constituent,

TITAN SIMAZINE 900 WG HERBICIDE (APVMA No. 62193)

PLUS OTHER REGISTERED PRODUCTS

Containing: 900 g/kg SIMAZINE as the only active constituent.

Directions for Use:

ALMONDS (Prunus amygdalus)	BROADLEAF WEEDS AND GRASSES	500 g/L product 1.7 – 3.5 L/ha
	As listed on product label.	900 g/kg product 1.0 – 2.0 kg/ha

Critical Use Comments:

- Use only if trees are at least three (3) years old.
- Apply to bare moist soil immediately after cultivation and before weeds emerge.

Withholding Period:

Not required when used as directed.

Jurisdiction:

ACT, NSW, NT, QLD, TAS & WA only.

Note: Victoria is not included in this permit, as their *Control-of-Use* legislation means a permit is not required to legalise this off-label use in that state.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

To Avoid Crop Damage

The sensitivity of the crop to be treated under this permit has not been fully evaluated. It is advisable to only treat a small area to ascertain the reaction before treating the whole crop.
