The Australian Horticulture Statistics Handbook

Each year Hort Innovation delivers an *Australian Horticulture Statistics Handbook* packed with horticulture statistical information and analysis for use by specific industries and the wider sector. Hort Frontiers projects

With seven investment areas, Hort Innovation's Hort Frontiers strategic partnership initiative is about collaborative, cross-industry work to address longer-term, complex issues and opportunities identified as critical for the future of Australian horticulture. While industry levies can be invested into Hort Frontiers projects upon the advice of the relevant Strategic Investment Advisory Panels, the bulk of funding comes from broad-reaching funding relationships that are secured by Hort Innovation, plus support from the Australian Government. Grant funding

In 2018/19, Hort Innovation delivered \$6.7 million worth of investments involving grant funding across the horticulture sector. To do so, we applied for and secured a range of competitive grants on behalf of industry, including through the Australian Government's Rural R&D for Profit program, Improved Access to AgVet Chemicals initiative, and Agricultural Competitiveness White Paper. With projects across everything from biosecurity to pollination, there's plenty in there to directly and indirectly benefit the pistachio industry.

Making investments in 2018/19

Hort Innovation is dedicated to making the right investments at the right time and in the right areas, in line with identified priorities for the industry.

Where the funding comes from

The pistachio industry's voluntary R&D levy is collected by the Pistachio Growers' Association and entrusted to Hort Innovation, under a collective industry fund (CIF) arrangement. It's then our responsibility to work with the industry to invest they levy, together with Australian Government contributions, into strategic initiatives for the benefit of growers.

Additional funding streams can also come into play, such as co-investment dollars from sources including project partners, and grant funding that Hort Innovation secures on behalf of industry.

How decisions are made

Investment decisions in the Hort Innovation Pistachio Fund are guided by the industry's investment plan. This document was developed by the industry and outlines specific investment priorities.

The plan is currently used like a 'roadmap' by the pistachio Strategic Investment Advisory Panel (SIAP) — a panel made up of growers and other industry representatives that's tasked with providing advice to Hort Innovation on potential levy investments.

Turning ideas into investments

Great investments start with great ideas, and Hort Innovation encourages all growers and other industry participants to share their thoughts and suggestions for the work they want to see. Ideas can be submitted any time via Hort Innovation's investment idea form at www.bit.ly/concept-form.

Ideas that are selected for investment are worked into project proposals by Hort Innovation. These are then made public for potential delivery partners to submit responses. Current opportunities are always listed at www.horticulture.com.au/delivery-partners.

Responses are assessed, often with the assistance of industry, and the best delivery partner for the work is chosen. A contract is then issued and the work begins.

Understanding and managing insects on pistachio orchards (PS16000)

Key research provider: Ag Dynamics

Beginning in late 2017, this project is responsible for increasing knowledge about pest and beneficial species of insects and mites in Australian pistachio orchards. In its course, it's helping the industry better understand the pests that currently pose a risk to pistachio production, or that have the potential to move into orchards. The work will also help the industry prioritise future research in pest management.

Technology transfer for pistachio growers (PS17002)

Key research provider: Pistachio Growers' Association

Beginning in 2018, this three-year investment is all about bringing the latest in Australian and international research, best practice and technical information to the nation's pistachio growers.

Project activities include, but aren't limited to:

- Maintaining and expanding the pistachio industry's regional 'Tech Groups'
- » Facilitating field days and farm walks throughout each year in the country's major pistachio growing regions, with involvement of Australian and international experts
- » Compiling technical information from Australia and overseas into resources for growers, including presentations, 'Seasonal Notes' that are distributed quarterly, e-bulletins and more
- » Updating of the industry website with new information (www.pgai.com.au)
- » Workshops for new entrants to the industry.

Pathogens and other factors contributing to dark staining on pistachio shells (PS16002)

Key research provider: AgXtra

Established in late 2017, this project is delving into dark staining of pistachio shells and nuts — an issue that significantly downgrades the value of the product and that has been tentatively linked to fungal pathogens Fusarium and Alternaria in preliminary studies.

Its work involves field and laboratory studies to evaluate the occurrence of dark staining and to provide information on causal agents associated with the problem. It is also looking at factors that could influence fungal infection, such as insect damage or environmental conditions.

The project will ultimately develop a monitoring tool for growers, to use in evaluating the risk of fungal disease, and assist in the future development of management strategies.

Pistachio productivity improvement program (PS17003)

Key research provider: Pistachio Growers' Association

Beginning in 2018, this investment supports improvements in the cultivation of pistachios and the uptake of new and changing production practices through research, development and extension activities.

It supports the role and activities of a pistachio researcher who, in conjunction with other research associates, is tasked with undertaking ongoing field research that builds on the outcomes of earlier project *Maintaining and expanding the technical development of the Australian pistachio industry* (PS14000), which was funded by industry contributions through the then Horticulture Australia Limited.

Goals of the work include:

- » Improving yields, through a better understanding of orchard management issues
- » Benchmarking and reporting on quality and yield information to growers
- » Assisting in disseminating information to growers, and in the adoption of R&D
- Supporting an increase in pistachio plantings
- Exploring new development areas for pistachio research
- » Responding to any changing environmental and seasonal issues that may arise.

Generation of residue data for permit applications (MT17012)

Key research provider: Eurofins

The generation of pesticide residue, efficacy and crop safety data is required to support label registration and minor use permit applications made to the Australian Pesticides and Veterinary Medicines Authority which, when approved, provide access to safe and effective chemicals for the management of pests, weeds and diseases.

Beginning in December 2017, this multi-industry investment is responsible for generating pesticide residue and crop safety data to support applications and renewals for a range of permits. For the pistachio industry, its results will be used to support a renewal of the industry's minor use permit for prochloraz, which is used in the control of anthracnose, panicle and shoot blight.
